## **BEQUESTS**

Thank you for your interest in making a bequest to the **Christadelphian Bible Mission of the Americas**. We are thankful that you are considering supporting this important work of the Lord.

Here are some of the ways you can help us with this work:

### DIFFERENT TYPES OF BEQUESTS

Through a bequest, you may leave the Bible Mission a specific dollar amount, or a certain percentage of your estate. You may stipulate whether the bequest is for the general support of the Bible Mission work or for a specific purpose.

There is no limitation on the size of the gift.

In addition to cash and marketable securities, gifts to the Bible Mission may include real estate, automobiles, or other property. All outright gifts to the Bible Mission should result in a charitable deduction for Federal Estate Taxes.

#### SUGGESTED FORMS OF BEQUESTS

When making or revising a will, you may want to consider consulting with an attorney. The Bible Mission will be pleased to work with you and your attorney. We encourage you to speak with us if you are interested in making a gift for a specific purpose, or a gift of property other than cash or marketable securities. It is our goal to assure that your gift intent is honored, and we look forward to working with you.

The following are sample forms for making various types of bequests:

## 1) Outright Bequest

# 2. Conditional or Restricted Bequest

(b) Restricted Use:

If the gift to the Bible Mission is for a purpose other than the unrestricted use as deemed appropriate by the Board, insert the restriction in place of the words "to be used or disposed of as its Board of Directors deems appropriate."

For example:

"I give the sum of \$\_\_\_\_\_ to the Christadelphian Bible Mission of the Americas, 567 Astorian Drive, Simi Valley, CA 93065 for the following use and purpose: [Describe Use or Purpose]." (Please note: due to the changing circumstances on the ground in Mission Areas, we do not recommend restricted donations as they can sometimes hamper the most effective work in the Lord's vineyard.)
